



AUTOMOTIVE REPAIR GARAGE STARTER GUIDE

A guide to opening your auto repair shop in Nova Scotia

CREATE YOUR BUSINESS

- **Create a business plan** that includes items such as: Market research, your organizational structure, a description of your facilities, revenue forecast and budgetary requirements.

There are various government agencies and other organizations that offer free help for planning, and start-up financial assistance (at various interest rates). Call a Business Navigator to find out more at 1-833-734-1300.

- **Request and secure a Business Name through the Registry of Joint Stocks** at [RJSC Connect](#) or contact 1-800-225-8227
- **Register your Business** within 90 days to ensure your business name is secured and to receive your unique Business Number.

Types of Businesses include sole proprietorships, partnerships and corporations. If choosing to incorporate, legal advice is recommended for preparation of documents.

- **Activate your Business Number** with CRA at 1-800-959-5525. Activation is mandatory if you have employees, you import or export, and/or your gross revenue exceeds \$30,000.
- **Workers Compensation Insurance** may be mandatory for your staff or an option you may want to consider. Contact WCB at 1-800-870-3331 or [www.wcb.ns.ca](#) to discuss your specific requirements. **Research any additional insurance** requirements such as liability and disability.

YOUR LOCATION

- **Next contact your municipality or town** to confirm your preferred location is zoned for your automotive garage type. In HRM, contact 311. Now that your location is approved, you must create a site plan.



CREATE YOUR SITE PLAN

Creating the layout of your garage is not only important for building and renovating, but for workplace safety. **Create a diagram or layout** of all rooms and doors, showing their sizes and use, include storage areas, and fire safety plan.

Source of water- if a well water supply is to be used, show the location of the well on your plan; if connected to a municipal or community supply, please indicate.

Sewage- if an on-site sewage disposal system is to be used, show the location of the system on your plan; if connected to a municipal or private collection system, please indicate.

Waste storage-

- Contact your municipality or town regarding water/oil separation units. For Halifax, contact 311.

Parking - show parking areas and driveways.

APPLY FOR PERMITS

Begin the permit process 3-6 months before opening.

Any garage, service station or car dealer in Nova Scotia who wants to conduct Motor Vehicle Inspections and participate in the program must be licensed to do so. Refer to [Motor Vehicle Inspection Station/Tester Licence](#) for information. Contact Service Nova Scotia at 1-800-898-7668 with any inquiries.

Contact Labour and Advanced Education – Technical Safety 1-800-952-2687 regarding air compressor regulations and certification.

Contact Occupational Health and Safety 1-800-952-2687 to determine your specific requirements around first aid, WHMIS, non-smoking areas, personal protective equipment, ventilation, and Workplace Safety Regulations.

If you are servicing in-vehicle **air conditioners**, please contact the Business Navigators or Nova Scotia Environment for a list of o-zone requirements.

For 'pre-opening' permits related to zoning, building, renovating and land development contact your municipality or town. In Halifax, contact 311.

For 'opening' permits such as occupancy, as well as fire prevention inspections and signage for your business, contact your municipality or town. In HRM, contact 311. It is important to note that your occupancy permit is required before fire prevention.

TRADE REQUIREMENTS

It is important to review the **Automotive Service Technician Trade Regulations** (<https://novascotia.ca/just/regulations/regs/atqauto.htm>) to understand what services you can provide as a journeyman, apprentice or an uncertified worker. The regulations also provide information on wage requirements.

Things to know -

- The automotive service technician trade is specified as a compulsory certified trade.
- For every 3 apprentices you must have 1 journeyman.
- An apprentice or journeyman is required to keep their identity card in their possession when on site and produce it on request.
- An automotive service technician journeyman must display their certificate of qualification in a easily visible location at their place of employment.
- The employer of an automotive service technician journeyman must provide suitable space for the display of the journeyman's certificate of qualification.

PREPARE FOR EXCELLENCE

Post all required signs, licences and permits as outlined.

Mark your calendar. Schedule equipment maintenance and set reminders to renew your permits and licences.

Be ready for inspections. Some happen quarterly, twice a year or once a year. You may not be notified of your inspection date.

For Employer/Employee obligations and rights including minimum wage, hours of work, terminations, vacation/holiday pay (etc.), contact the **Nova Scotia Labour Standards Division** at 1-888-315-0110.

Automotive repair garages may be required to hire private companies for **garbage and recycling collection**

Contact your municipality or town to determine who in your area is an authorized collector. In Halifax, contact 311.
